1. Anvendelsesområde

Damixas udendørsprodukter er produceret i højkvalitets rustfri stål, AISI 316 (EN 1.4401) ¹.

Produktet er udviklet til privat brug og designet til:

- Udendørs installation i helårsmiljø
 - Frostsikre produkter har indbygget automatisk tømmefunktion. Funktionen forudsætter, at der ikke er tilkoblet eksterne komponenter (slanger, koblinger eller lignende)
 - Produkter uden "frostsikker" mærkning skal tømmes helt efter brug og alle eksterne tilkoblinger skal demonteres.
- Eksponering for fugt, nedbør og varierende temperaturforhold
- Brug i kystnære områder med moderat saltpåvirkning

¹ Selv om overfladerne er udviklet til at klare de fleste forhold, kan der forekomme overfladeændringer over tid. Dette er helt naturligt og har ingen indflydelse på funktion eller brug.

2. Installation

Installationer udført med fast installation skal udføres af autoriseret VVS-installatør og i henhold til gældende nationale forskrifter.

- For frostsikre produkter skal installationen udføres så vandtilførslen til ventilerne til en hver tid er beskyttet mod frost.

3. Vedligeholdelse

For at bevare produktets udseende og korrosionsbestandighed anbefales:

- Regelmæssig rengøring med mild sæbeopløsning med efterfølgende grundig afskylning med rent ferskvand.
- Afskylning med rent ferskvand jævnligt i kystnære områder
- Tørring ved behov, med blød klud, for at reducere overfladeaflejringer
- For rå rustfri overflader anbefales det at påføre et tyndt lag syrefri olie umiddelbart efter montering og derefter 1-2 gange årligt. Dette reducerer risikoen for flyverust².
- Ved produkt med drænventil (varm/kold frostsikre produkter) skal der ved afslutning af bad sikres at ventilen dræner (vand drænes under ud efter luk af afspærring).
- Det anbefales at tømme ventilen aktiveres jævnligt for at undgå fastgroning.

Anvendelse af syreholdige, klorbaserede eller slibende rengøringsmidler ikke tilladt.

² Flyverust er små rustpartikler fra omgivelserne (fx jernstøv eller forurening), som sætter sig på den rustfri overflade. Selvom materialet i sig selv er rustfrit, kan disse partikler give overfladiske rustpletter, hvis de ikke fjernes eller beskyttes imod.

Garantien omfatter ikke:

- Frostskeer på produkter der ikke er frostsikre
- Frostskeer på frostsikre produkter forårsaget af manglende demontering af eksterne komponenter (Slange, koblinger eller lignende)
- Frostskeer som følge af ikke funktionel drænventil.
- Skader som følge af forkert installation eller manglende overholdelse af forskrifter
- Forkert brug eller anvendelse uden for produktets anvendelsesområde
- Skader som følge af ydre påvirkninger ud over normal anvendelse, herunder ekstreme vejrforhold eller aggressive miljøer³
- Kalk-, klor-, salt- eller kemikalierelaterede skader
- Skader forårsaget af urenheder i vandet
- Manglende eller forkert vedligeholdelse (jf. Damixas rengøringsvejledning)

Damixa kan ikke holdes ansvarlig for indirekte tab, driftstab eller følgeskader, medmindre andet følger af ufravigelig lovgivning.

1. Scope of Application

Damixa's outdoor products are manufactured in high-quality stainless steel, AISI 316 (EN 1.4401)¹. The product is developed for private use and designed for:

Outdoor installation in year-round environments

- Frost-proof products have a built-in automatic draining function. This function requires that no external components (hoses, connectors, or similar) are attached.
- Products without "frost-proof" marking must be completely drained after use, and all external connections must be removed.
- Exposure to moisture, precipitation, and varying temperature conditions
- Use in coastal areas with moderate salt exposure

¹ Although the surfaces are designed to withstand most conditions, surface changes may occur over time. This is completely natural and does not affect functionality or use.

2. Installation

Fixed installations must be carried out by an authorized plumber and in accordance with applicable national regulations.

- For frost-proof products, installation must ensure that the water supply to the valves is protected from freezing at all times.

3. Maintenance

To maintain the product's appearance and corrosion resistance, the following is recommended:

- Regular cleaning with a mild soap solution followed by thorough rinsing with clean fresh water
- Regular rinsing with clean fresh water in coastal areas
- Drying when necessary using a soft cloth to reduce surface deposits
- For brushed/raw stainless steel surfaces, it is recommended to apply a thin layer of acid-free oil immediately after installation and then 1–2 times annually. This reduces the risk of tea staining²
- For products with a drain valve (hot/cold frost-proof products), ensure after use that the valve drains properly (water drains after closing the shut-off valves)
- It is recommended to activate the drain valve regularly to prevent blockage

The use of acidic, chlorine-based, or abrasive cleaning agents is not permitted.

² Tea staining consists of small rust particles from the surroundings (e.g. iron dust or pollution) that settle on the stainless surface. Although the material itself is stainless, these particles may cause surface rust stains if not removed or protected against.

4. Warranty Conditions

The warranty does not cover:

- Frost damage to products that are not frost-resistant.
- Frost damage to frost-proof products caused by failure to remove external components (hoses, connectors, or similar)
- Frost damage caused by a non-functioning drain valve
- Damage resulting from incorrect installation or failure to comply with regulations
- Misuse or use outside the product's intended application
- Damage caused by external influences beyond normal use, including extreme weather conditions or aggressive environments³
- Damage caused by limescale, chlorine, salt, or chemicals
- Damage caused by impurities in the water
- Lack of maintenance or incorrect maintenance (cf. Damixa's cleaning guide)
- Surface corrosion and aesthetic changes without functional impact, including "tea staining," "surface rust," and discoloration
- Normal signs of use (scratches, discoloration, dents, etc.)
- Normal wear and tear
- Costs related to removal, reinstallation, or consequential damages
- Consequential damages resulting from incorrect repairs

³ Particularly aggressive environments may include areas with high salt concentration, chlorinated pool atmospheres, strong UV exposure, or similar conditions.
